2021 main sewer lines – repair project:

- Erik Hoovestol will contact Iron Horse to get the final Invoice.
- The Board would like a non-monetary change order with Iron Horse, for the items that were not completed this summer.

# Generator replacement for the Treatment Plant:

- The District received a \$10,000 dollar grant from the Special District Insurance Services.
- The funds will be used towards the purchase of a new Generator at the Treatment plant next summer.

# Damage to Manhole AS26 – Hwy 26:

• James Peterson from ODOT said they will repair the manhole next spring.

# FEMA grant – Project #167003:

- In April 2021, the Sanitary District received a grant for 75% of the cost accrued from the 2020 PGE power outage.
- An amendment was recently created by FEMA for cost alignment and is currently under review for reimbursing 100% of the District's expenses during the power outage.

# Mt. Hood Brewing, Account #159, 87304 E Gov't Camp Loop:

- Brian Borgmeier from Mt. Hood Brewing discussed options with the Board about connecting to the Sewer District in the near future.
- The Board agreed to have the District's Plant Operators perform testing on the Brewery system to determine if it is feasible to connect.
- Once testing is completed, the Board will review the information to determine the SDC fees.

# Manhole #CS2. damage by the corner of 30609 E Ski Haus Lane:

- The manhole's casting was recently knocked off while removing the snow on Ski Haus Lane.
- Andrew Tagliafico mentioned that Gov't Camp Snow Removal replaced the casting, regrouted and applied concrete around the lid. Pavement repair will need to take place next summer to avoid further damage.

### Manhole #AS7 – Skibowl West parking lot near the Treatment plant:

- Andrew Tagliafico mentioned that the casting was blown off the manhole when removing snow.
- Casting was placed back in position but will need further repair next summer.

### Huckleberry Inn – 88611 E Government Camp Loop, Account #131:

- Ed Rogers Jr. informed the Board that he will be converting the retail space below the Hotel into nightly lodging.
- The lodging space will be one unit and occupy 12 max. The EDU and SDC rate will be changed from 1.0 to 1.50, once completed.
- One SDC has been paid on this space, so an additional half SDC fee will be billed to Huckleberry Inn for \$2,750.10.

There being no further business, the meeting was adjourned.
