At the prior meeting, the Board requested the time frame when the owner was watering excessively due to new shrubs planted around the house.

On February 24, 2021, the owner stated that they believe they watered June through November 2020.

The Board agreed that no credit would be issued due to the fact that the 2019-meter rate was higher than 2020.

The District Secretary will notify the owner and suggest that they install an irrigation meter.

30500 E West Leg Road, Account #184, Mazamas Lodge:

December 8, 2020 - Sarah Bradham from Mazamas Lodge requested a refund for past services and temporary reduction on their sewer fees for the Lodging portion, due to COVID-19 limitations set by the State of Oregon and the Forest Service Special use permit restrictions in place from mid-March through June 1, 2020.

December 14, 2020 - the Board stated if Mazamas Lodge can provide documentation from the Forest Service, stating they were prohibited from lodging, the District would consider a possible rate reduction.

February 9, 2021 – Email received from Sarah Bradham/Mazamas Lodge -

From our permit administrator on March 26, 2020: "This email is for permit holders with recreation facilities or services on the Mt. Hood National Forest. I am sending this quick note to share new information about recreation on the Forest as of today. Attached is a press release that came out this afternoon. In short, all developed recreation sites on the Mt. Hood NF are temporarily closed until at least May 8. The spread of COVID-19, the Governor's Stay Home, Save Lives order, and this closure have no doubt affected spring operations for many recreation special use permit holders."

30500 E West Leg Road, Account #184 – Mazamas Lodge continued.

From our permit administrator on May 20, 2020 - the portion in red is critical as this was the line that has prevented us from reopening, as according to county guidelines, we don't have the ability to open since our building is for social gatherings which would be more than 6 people from multiple households.

"I will share more as I learn it. For now, please send me any plan or protocol for COVID-19 safety and mitigation you have and look at May 29th as the first day you may be able to consider resuming operations. You will still need to comply with all terms and conditions of your permit which include:

- only conducting operations of activities at locations and within the timeframe of which you are specifically authorized."

The Board would like a copy of the Forest Service email notices sent to Mazamas Lodge back from March 26, 2020, regarding their limitations on operations.

<u>Board member elections – May 18, 2021:</u> Cornelia Gunderson and John Bay have agreed to run again for Board positions #2 & 4.

<u>2021 main sewer lines – repair project:</u> No updates.

2021 main sewer lines – cleaning/inspection project:
