Main line to Mazamas was inspected and the video will be reviewed to determine if repairs are needed.

Erik Hoovestol from Firwood Design Group completed the final design for the Influent pipe repair at the Treatment Plant Headworks building.

Firwood submitted to Jim Turin and Sons Inc. for a quote on the repair.

#### Resolution #2021-215 – Adopting the 2021-22 FY Budget:

Ed Rogers Jr. moved to adopt Resolution #2021-215, for the 2021-2022 FY Budget in the amount of \$1,515,434.00. Seconded by Cornelia Gunderson. Motion passed.

#### <u>Clackamas County Special District Elections – May 18, 2021:</u>

GCSD Board position # 2 and #4 were up for elections on May 18, 2021.

John Bay and Dan Mancuso ran for position #2. John Bay received 12 votes and Dan Mancuso received 19 votes.

Cornelia Gunderson ran unopposed for position #4 and received 27 votes.

Dan Mancuso and Cornelia Gunderson's Board position will start on July 1, 2021.
